## Subject:

Written Procedure for **modification of the Programme document of INTERREG - IPA CBC Programme (2014TC1615CB006) and inclusion of "State Aid and Real Sector" Directorate in the Ministry of Finance of Republic of Bulgaria** in the JMC institutional composition with an advisory capacity

According to article 7, paragraph (1) and paragraph (2) of the Rules of Procedure of the Joint Monitoring Committee (JMC), on 29<sup>th</sup> of February 2016 Managing Authority initiated a written procedure for

1. Modification of the the Programme document of INTERREG - IPA CBC Programme between Republic of Bulgaria and Republic of Macedonia 2014-2020 in terms of inclusion of the set baseline and target values for the qualitative Programme result indicators in accordance with the provisions of Art. 8 of Regulation (EU) No 1299/2013;
2. Proposal for inclusion of "State Aid and Real Sector" Directorate in the Ministry of Finance of Republic of Bulgaria in the JMC institutional composition with an advisory capacity.


In accordance with Article 7, paragraph (3) of the Rules of procedure of the JMC, the JMC members had been given **10 working days** from dispatch of the proposal to respond in writing. The deadline for comments/approval was **15<sup>th</sup> of March 2016**.


