

## **JOINT MONITORING COMMITTEE**

**under Interreg - IPA CBC Bulgaria - the former Yugoslav Republic of Macedonia**

**Written procedure No.11, initiated on 19.04.2017**

---

### **1. Description:**

On 19<sup>th</sup> of April 2017 a decision making procedure in writing for approval of contract modification under the project No CB006.1.23.196 "Interregional Tourism through Cultures (subsidy contract No РД-02-12-213/17.10.2016) with Lead partner Association "International Initiatives for Cooperation " Razlog and project partner 2 Minority Leaders for Society - MLS Stip, financed under First Call for proposals of the Interreg – IPA CBC Bulgaria - the former Yugoslav Republic of Macedonia Programme 2014-2020 was initiated.

The contract modification envisages budget reallocation between project partners as 2400 EUR (accumulated from budget line 4 "External expertise and services costs") of the budget of Project partner 2 is transferred to the budget of the Lead partner (budget line 4"External expertise and services costs", budget subline 4.7. "Accommodation for participants in the events"). Thus the total amount of budget line "External expertise and services costs" in the budget of the Lead partner is increased to 31 535 EUR and the total amount of budget line "External expertise and services costs" in the budget of the Project partner 2 is decreased to 16 600 EUR.

In accordance with Art. 7 (3) of the Rules of procedure, the JMC members had been given 10 working days from dispatch of the document to respond in writing. The deadline for comments/approval was 03<sup>th</sup> of May 2017.

No written objections had been received within the given deadline and it can be concluded that the JMC approves the enclosed documents.

### **2. Decisions:**

JMC approves contract modification (budget reallocation between project partners) under the project No CB006.1.23.196 "Interregional Tourism through Cultures (subsidy contract No РД-02-12-213/17.10.2016) with Lead partner Association "International Initiatives for Cooperation " Razlog and

project partner 2 Minority Leaders for Society - MLS Stip, financed under First Call for proposals of the Interreg – IPA CBC Bulgaria - the former Yugoslav Republic of Macedonia Programme 2014-2020.

The hereby Decision enters into force on the 04<sup>th</sup> of May 2017 - the date following the deadline for submission of approval/objections/additional proposals/comments from JMC members.
