#### 1. Description:

On 5<sup>th</sup> of September 2022 with official letter 99-00-2-219-05.09.2022, a decision making procedure in writing for approval of documents related to management and implementation of the Interreg – IPA CBC Programme 2014-2020 between Republic of Bulgaria and Republic of North Macedonia, was initiated by the Managing Authority – Ministry of Regional Development and Public Works of Republic of Bulgaria.
