**Written procedure No.16, initiated on 31.10.2017**

### **1. Description:**

On 31<sup>st</sup> of October 2017 a decision making procedure in writing for approval of requests for modifications of subsidy contracts under the First Call for Proposals:

- request for extension of the implementation period under project with ref. No CB006.1.21.104 "Building the bridge of tourism - blend of common heritage" with Lead partner Staro Nagoricane Municipality, and Project partner 2 - Municipality of Rila;
- request for inclusion of own co-financing to the budget under project with ref. No CB006.1.11.038 "Green building for common green future - GREEN" with Lead partner Centre for Development of the East Planning Region and Project partner 2 - Regional Administration Blagoevgrad.

In accordance with Art. 7 (3) of the Rules of procedure of the Joint Monitoring Committee, the JMC members had been given 10 (ten) working days from dispatch of the documents to respond in writing. The deadline for comments/approval was 13<sup>th</sup> of November 2017.

The only remarks received by the JMC members, within the set deadline, were opinions of approval and it can be concluded that the JMC approves the requests for modifications of the subsidy contracts.

### **2. Decisions:**

**JMC approves the following requests for modifications of subsidy contracts under the First Call for Proposals:**

- request for extension of the implementation period under project with ref. No CB006.1.21.104 "Building the bridge of tourism - blend of common heritage" from 18 to 24 months;
- request for inclusion of own co-financing amounting to EUR 10 244,35 to the budget of the Lead partner under project with ref. No CB006.1.11.038 "Green building for common green future - GREEN".

The hereby Decision enters into force on the 14<sup>th</sup> of November


