Written procedure No.22, initiated on 27.07.2018

1. Description:

On 27th of July 2018 a decision making procedure in writing for approval of the results from Step 1 – Preliminary session and verification of submitted proposals and Step 2 - Administrative compliance and eligibility check of the project proposals under the 2nd Call for Proposals of the Interreg – IPA CBC Programme Bulgaria - the former Yugoslav Republic of Macedonia 2014-2020 was initiated by the Managing Authority – Ministry of Regional Development and Public Works, Bulgaria.

The official letter No 99-00-2-729/27.07.2018 was sent to the JMC members via e-mail and the attachments 1. Evaluation Report Step 1 – Preliminary Session and Verification of Submitted Proposals and 2. Evaluation Report Step 2 – Administrative compliance and eligibility check were made available in the JMC section of the Management Information System.

In accordance with Art. 7 (3) of the Rules of procedure of the Joint Monitoring Committee, the JMC members had been given 10 (ten) working days from dispatch of the documents to respond in writing. The deadline for comments/approval was 10th of August 2018.

No written objections had been received within the given deadline, and it can be concluded that the JMC approves the enclosed documents.

JMC approves the Evaluation Report Step 1 – Preliminary Session and Verification of Submitted Proposals and the Evaluation Report Step 2 – Administrative compliance and eligibility check under the 2nd Call for Proposals of the Interreg – IPA CBC Bulgaria – the former Yugoslav Republic of Macedonia 2014-2020.


