Written procedure No. 35, initiated on 19.05.2020

1. Description:

On 19th of May 2020 with official letter № 99-00-2-148/19.05.2020, a written procedure for approval of modification of the Interreg-IPA CBC Programme between Republic of Bulgaria and Republic of North Macedonia 2014-2020 related to change of the target values of the Programme Output indicators (OIs) was initiated by the Managing Authority.

In accordance with Articles 7 of the Rules of Procedure of the Joint Monitoring Committee (JMC), the following documents related to management and implementation of Interreg-IPA CBC Programme between Republic of Bulgaria and Republic of North Macedonia 2014-2020 by the end of the programming period, were sent to JMC members for consideration and approval:

- 1. Approval of the analysis and the proposed revision of the Ols;
- Approval of the revised Programme based on the proposals under p. 1;
- Giving mandate to the Managing bodies to finalize the negotiations with the European Commission in relation with the revision of the Programme initiated by decision of the JMC No 33 from 12.12.2019.

In accordance with Art. 7 of the Rules of procedure of the Joint Monitoring Committee, the JMC members had been given 3 (three) working days from dispatch of the documents to respond in writing.

The deadline for comments / approval was 22nd of May 2020.

No written objections had been received within the given deadline, and it can be concluded that the JMC approves the enclosed documents.

- 1. Analysis and the proposed revision of the Ols;
- 2. Revised Programme based on the proposals under p. 1;
- 3. Giving mandate to the Managing bodies to finalize the negotiations

with the European Commission in relation with the revision of the Programme initiated by decision of the JMC No 33 from 12.12.2019
