**1. Description:**

On 21<sup>th</sup> of May 2020 with official letter № 99-00-2-153/21.05.2020, a written procedure for approval of Pre-contracting report from the performed on the spot visits and budget optimization of the projects from the reserve lists provisionally selected for financing under the Second Call for Proposals No 2014TC16I5CB006 – 2018 – 2 was initiated by the Managing Authority.

In accordance with Articles 7 of the Rules of Procedure of the Joint Monitoring Committee (JMC), the following documents related to Pre-contracting report from the performed on the spot visits and budget optimization of the projects from the reserve lists provisionally selected for financing under the Second Call for Proposals No 2014TC16I5CB006 – 2018 – 2 of Interreg-IPA CBC Programme between Republic of Bulgaria and Republic of North Macedonia 2014-2020, were sent to JMC members for consideration and approval:


