Written procedure No.37, initiated on 07.08.2020

1. Description:

On 10th of August 2020 a decision making procedure in writing for approval of the 2019 Annual Implementation Report under the Interreg – IPA CBC Programme between Republic of Bulgaria and Republic of North Macedonia 2014-2020 was initiated by the Managing Authority Ministry of Regional Development and Public Works, Bulgaria.

The official letter No 99-00-2-216/07.08.2020 was sent to the JMC members via e-mail and attached 2019 Annual Implementation Report under the INTERREG - IPA CBC Programme between Republic of Bulgaria and Republic of North Macedonia 2014-2020 and Citizen's summary 2019 were made available in the JMC section of the Management Information System.

The 2019 AIR has been prepared by the Managing Authority and the Joint Secretariat in cooperation with the National Authority in accordance with the provisions of Article 42(1) of Commission Implementing Regulation (EU) No 447/2014 in relation to Article 50(2) of Regulation (EU) No 1303/2013 and Article 14(3)(a) of Regulation (EU) No 1299/2013.

The 2019 AIR report contains information about implementation of the projects financed under the 2nd Call for Proposals, financial data per priority axis and Programme level as well as the results with regard to achievement of the Programme output indicators in 2019. Upon its approval by the JMC the AIR should be submitted to the European Commission.

In accordance with Art. 7 of the Rules of procedure of the Joint Monitoring Committee, the JMC members had been given 10 (ten) working days from dispatch of the documents to respond in writing.

The deadline for comments/approval was 21th of August 2020.

No written objections had been received within the given deadline, and it can be concluded that the JMC approves the 2019 Annual Implementation report under the INTERREG – IPA CBC Programme between Republic of Bulgaria and Republic of North Macedonia 2014-2020 with Citizen's Summary 2019.
