1. Description:

On 24th of August 2022 with official letter 99-00-2-213/24.08.2022, a decision making procedure in writing for approval of the Evaluation report from the performed assessment under the Call for proposals for preparatory activities of the strategic project for construction/rehabilitation of a new Border cross check point (BCCP) Strumyani – Berovo, financed under Technical Assistance of the Interreg – IPA CBC Programme between Republic of Bulgaria and Republic of North Macedonia 2014-2020, was initiated by the Managing Authority – Ministry of Regional Development and Public Works of Republic of Bulgaria.

In accordance with Articles 7 of the Rules of Procedure of the Joint Monitoring Committee (JMC), the documents related to Evaluation Report were sent to JMC members for consideration and approval.

In accordance with Article 7 (4) of the Rules of procedure of the Joint Monitoring Committee, the JMC members had been given 3 (three) working days from dispatch of the documents to respond in writing. The deadline for comments/approval was 29th of August 2022.
