## 1. Description:

On 24<sup>th</sup> of August 2022 with official letter 99-00-2-213/24.08.2022, a decision making procedure in writing for approval of the Evaluation report from the performed assessment under the Call for proposals for preparatory activities of the strategic project for construction/rehabilitation of a new Border cross check point (BCCP) Strumyani – Berovo, financed under Technical Assistance of the Interreg – IPA CBC Programme between Republic of Bulgaria and Republic of North Macedonia 2014-2020, was initiated by the Managing Authority – Ministry of Regional Development and Public Works of Republic of Bulgaria.
