**Written procedure No.01, initiated on 12.12.2022****1. Description:**

On 12<sup>th</sup> of December 2022 with official letter No 99-00-2-310/12.12.2022, a decision making procedure in writing for approval of the measures related to the use of funds under Priority Axis 4 "Technical Assistance" of INTERREG – IPA CBC Programme 2014-2020 CCI 2014TC16I5CB006 for financing the preparatory activities under the strategic project of the future CBC Programme 2021-2027, was initiated by the Managing Authority – Ministry of Regional Development and Public Works of Republic of Bulgaria.

In accordance with Articles 7 (1) and 7 (2) of the Rules of Procedure of the Monitoring Committee (MC), the relevant documents for measures related to the use of the funds under Priority Axis 4 "Technical Assistance" of Interreg-IPA CBC Programme 2014-2020 (CCI 2014TC16I5CB006) for financing the preparatory activities of the strategic project of the IPA III Programme 2021-2027, were sent to MC members for consideration and approval:

1. Reallocation of the funds within Priority Axis 4 "Technical Assistance" for financing the additional activities under the project with ref. No TA\_ExB\_2022.0.003;

In accordance with Article 7 (4) of the Rules of procedure of the Monitoring Committee, the MC members had been given 5 (five) working days from dispatch of the documents to respond in writing. The deadline for comments/approval was 19<sup>th</sup> of December 2022.

No written objections, additional proposals or comments have been received within the given deadline, and it can be concluded that the MC approves the proposed measures.
