Written procedure No.02, initiated on 19.01.2023

1. Description:

On 19th of January 2023 with official letter No 99-00-2-34/19.01.2023, a decision making procedure in writing for approval of the modification of project with ref. No TA_ExB_2022.0.002 and amendment of the Eligibility of Technical Assistance Expenditures under the Interreg – IPA CBC Programme between Republic of Bulgaria and Republic of North Macedonia 2014-2020, was initiated by the Managing Authority – Ministry of Regional Development and Public Works of Republic of Bulgaria.

In accordance with Articles 7 (1) and 7 (2) of the Rules of Procedure of the Monitoring Committee (MC) of the INTERREG (VI-A) IPA Bulgaria – North Macedonia Programme 2021-2027, the following documents were sent to MC members for consideration and approval:

1. Request for modification of the project with ref. No TA_ExB_2022.0.002;
2. Amended Eligibility of Technical Assistance Expenditures of the Interreg-IPA CBC Programme 2014-2020 related to the remuneration of the staff in the First Level Control Unit (FLC) in Territorial Cooperation Management Directorate (Managing Authority), MRDPW.

In accordance with Article 7 (4) of the Rules of procedure of the Monitoring Committee, the MC members had been given 5 (five) working days from dispatch of the documents to respond in writing. The deadline for comments/approval was 26th of January 2023.

No written objections, additional proposals or comments have been received within the given deadline, and it can be concluded that the MC approves the proposed measures.

2. Decisions: The Monitoring Committee approves:

1. Modification of the project with ref. No TA_ExB_2022.0.002;
2. Amendment of Eligibility of Technical Assistance Expenditures of the Interreg - IPA CBC Programme 2014-2020 concerns the remuneration of the staff in the First Level Control Unit (FLC) for Bulgaria.
